Curtain and blind cords

Cords used to control curtains and blinds can be dangerous. Avoid the risk of children strangling themselves by keeping cords out of their reach.

From 31 December 2008, the Minister for Consumer Affairs has banned the supply of window coverings that do not meet certain safety standards. See 'New curtains or blinds' below for more information.

The risks

Children in Australia and overseas have died as a result of strangulation by curtain or blind cords. It can take only a few seconds for a baby or young child to become entangled, especially if the cords are too long and form a loop. Playing with a curtain or blind cord can turn it into a noose around a child's neck.

Safety tips

- Move all nursery furniture—such as cots, beds, high chairs or playpens—away from windows or doors, where a child can reach the curtain or blind cord.
- Do not place household furniture that could be climbed—such as sofas, chairs, tables, shelves or bookcases—near windows with curtain or blind cords in reach.

New curtains or blinds

Full details of the mandatory safety requirements for new curtains and blinds can be found on the Consumer Affairs Victoria website, www.consumer.vic.gov.au, under 'Banned and regulated products'. The following information is a summary only.

- Any exposed looped cord, looped bead chain or other flexible looped device should be at least 160cm above the floor when the covering is in its lowered position.
- Written information must be supplied with the product that explains:
 - · how to install the covering
 - how to install any safety device the covering has
 - how the safety device is designed to function.
- The product must carry the following warning label:

WARNING Looped cords, looped bead chains or other flexible looped devices may cause a strangulation hazard for children under 5 years.

KEEP CORDS AND CHAINS OUT OF REACH OF CHILDREN

If you are ordering new, made-tomeasure curtains or blinds, ask the supplier to show you what safety features or child-safe products are available to ensure the cords are not a strangulation hazard.

Making existing curtains or blinds safer

Curtain and blind cords with loops can be made safer in a number of different ways:


Attach a cleat

Attach a cleat to the wall or window frame near the top of the curtain or blind, at a height of 160 cm or more from the floor, and wrap the cord around the cleat.



Cut the cord

Cut the cord in half to get rid of the loop. Remove the end tassel and equaliser buckle. Then attach a tassel to each of the cord ends and knot the ends to hold the tassels in place.





Use a tie-down

Cords or chains on vertical blinds and some curtains need a continuous loop to operate and cannot be cut. Use a tie-down or tension device and fix it securely to the floor or to the wall near the floor so that the cord is pulled tight.
